FEATURED SPEAKERS

Becky Lewis- Becky Lewis received her B.A. from Stanford University, and her law degree from Duke University School of Law. She is licensed to practice law in Wyoming, Colorado and California (now inactive). She practiced in a large firm in Los Angeles for nearly four years before returning to Wyoming where she was born and raised. Becky is Chief Bar Counsel for the Wyoming State Bar. Becky also continues to do some private litigation on a limited basis as a partner with Pence and MacMillan. Becky was an adjunct professor of law at the University of Wyoming College of Law from 1999-2006, where she taught insurance law, lawyering skills, and civil pretrial practice. Becky served on the Board of Law Examiners. Character and Fitness Committee from 2000-2002 and was a member of the Board of Professional Responsibility from 1991 to 1997. She was also a member of the Wyoming State Bar Foundation Board of Directors from 1996 to 2001.
